

NPG's "WAKE UP AMERICA!" CAMPAIGN ...300 MILLION AND COUNTING!


NPG takes great pride in the fact that we are the foremost grassroots organization in America dedicated to informing and educating students, citizens and elected officials about population issues.

POPULATION EXPERTS SPEAK OUT ON 300 MILLION AMERICANS:

NPG will celebrate its 35th Anniversary in 2007. During that period a number of extraordinarily talented population experts and researchers have published their findings in NPG Forum Papers. These serve to better educate the American people and our local, state, and national policymakers about the devastating effects of overpopulation on our resources, environment and quality of life. Today, as our nation reaches a level of 300 million people, we asked some of these friends to succinctly share their thoughts on this notable milestone.

CONDOLENCES ON 300 MILLION

If any fraction of the observed global warming can be attributed to the activities of humans, then this constitutes positive proof that the human population, living as we do, has exceeded the carrying capacity of the Earth.

THIS SITUATION IS NOT SUSTAINABLE!

As a consequence, it is AN INCONVENIENT TRUTH that all proposals or efforts to slow global warming or to move toward sustainability are serious intellectual frauds if they do not advocate reducing population to a sustainable level at the local, national and global scales.

As we reach 300 million, why is the media so enthusiastic about it? Why don't they ever point out that population growth is one of the root causes of so many of our problems: pollution; traffic; overcrowded schools; crime the list goes on. When will they ever learn?

That is a non-event, the product of the Census Bureau's estimating processes. We probably crossed 300 million some time ago. Recent decennial Census counts have shown that the Bureau regularly underestimates growth, and the counts themselves are undercounts, judging by the Bureau's own sampling.

Nevertheless, the fact that we are somewhere above 300 million, and growing faster than the experts guess, tells us something important. At a time when we are on the way

to double again in this century, largely because of immigration and immigrants' fertility, U.S. population growth should be at the center of the present debate about immigration policies. It has hardly been mentioned.

With the US population increasing per person twice as fast as China, we can expect intense pressure on all our vital resources. These include fertile cropland, freshwater, food, and energy resources. Our personal freedoms will also suffer.

This nation has added 100 million people since 1967, 53 million of them through immigration – nearly one-third of it illegal – and births to immigrants. Immigration has even greater momentum now, and population growth cannot be stopped without halting all illegal immigration and reducing snowballing legal immigration by four-fifths.

THE CBO'S SHOCKING IMMIGRATION COSTS

The Congressional Budget Office (CBO) is recognized as a non-partisan group that simply crunches the numbers and puts a price tag on what Congress proposes and passes.

So when the CBO came out in late August with an estimate that the Senate-passed immigration bill would cost American taxpayers \$126 billion – not million, BILLION – over the next ten years, it raised quite a few eyebrows in Washington and added a new monetary dimension to the already roiling debate on immigration reform legislation.

In reporting on the CBO's report, the *Washington Post* noted that it was the “most detailed analysis to date” of this legislation that is sure to “offer fuel for that fight.” For groups like NPG and others who are fighting against the broad guest-worker and amnesty provisions of the Senate bill and working hard to spread the news about its costly and very destructive long-term consequences, it is good that we now have solid dollar estimates to bolster our arguments against this costly legislation.

Certainly, had the CBO not released these startling figures on a Friday evening when Congress, national policymakers and top news writers are all absent from the

nation's capital during the August recess, they would have received much more attention in the media.

Lost in the news stories on the CBO report was their enumeration of the plan's impact on the population. The *Post* story noted: “By 2016, CBO researchers estimate, more than 16 million people would either become legal permanent residents under the bill or obtain some other legal status. That total would include 4.4 million undocumented workers, 3.3 million guest workers and 2.6 million family members brought in through new programs. By 2026, the addition to the U.S. population would jump to 24.4 million.”

The Senate immigration bill would cost \$126 BILLION.

These CBO population numbers are amazingly small and only add more confusion to the immigrant numbers game that has been going on for months. The Heritage Foundation put forth a respected research study in May that put the long range estimate of new immigrants over 20 years as high as 106 million. And Senator Jeff Sessions' well-researched analysis of new immigrants during debate on the Senate bill estimated the number of new people over the next two decades as high as 66 million. The task of NPG members is to work extra hard to ensure that future immigration numbers are as minimal as possible.

As it stands, the CBO numbers on both the costs of increased immigration and the total number of new arrivals have to be taken with a grain of salt as official numbers all too often fall far short of real numbers.

MAKE YOUR VOTE COUNT THIS NOVEMBER

In our quest to get control of America's borders and put realistic limits on future immigration we are fighting a battle that is important to all Americans – but especially to future generations who will have to live with the dire consequences of uncontrolled population growth. We owe it to them to elect leaders today who will provide responsible leadership in reforming our immigration laws.

Toward this end, we urge all NPG members to access the *NumbersUSA* website to review the “Americans for Better Immigration – Immigration Reduction Report Card” that they have posted for every current member of the U.S.

Senate and U.S. House of Representatives. Incumbent legislators are rated “A” through “D-” on the votes they have cast on individual issues such as chain migration, visa lottery, foreign workers, refugee and asylum, anchor baby citizenship, border control, interior enforcement and benefits for illegal aliens. They are then given an overall grade. Challengers are rated on their responses to questionnaires on the immigration issue.

NumbersUSA makes it clear that their grading contains no bias toward or against any political party or any politician – a computer calculates the grades based on the effect of each action for either increasing or reducing immigration numbers (legal and illegal). A quick review of
