PRESIDENT'S COLUMN

Numbers are – and always have been – a powerful part of any discussion of population growth. Yet sometimes it's much more effective to get the point across about the real impact of population numbers by putting the issue in a context people can more easily comprehend.

Over the years I have found that in personal conversations, citing a standard statistic such as "The U.S. Census Bureau estimates that we add 250,000 people to our nation's population each month" is traditionally met with a nod of concern.

However, the statement that would get people thinking more clearly is: "The U.S. Census Bureau estimates that America grows by 250,000 people – an amount equal to the population of St. Petersburg, Florida or Ft. Wayne, Indiana – each month." They understand that you are talking about huge numbers of people who will need all of the amenities of a major city.

I bring this up because in the coming months, as we work with members of Congress to create a U.S. Commission on Population Growth, it's not enough to simply state that America's population will soar to 450 million people by 2050. Our legislators live in a world where they are used to dealing with figures in the billions and trillions. Thus, a million –

BUILDING A GRASSROOTS MOVEMENT

Great movements often start small. Yet, with the commitment and tenacity of growing waves of people who believe in the cause, they grow to become a powerful force. Such is the case with the environmental movement which hardly existed 50 years ago but today plays an influential role in driving many aspects of national and international policy.

In recent weeks Negative Population Growth has contacted each member of Congress asking them to sponsor and help advance legislation that will create a long-overdue U.S. Commission on Population Growth. It is the first step toward a responsible National Population Policy.

In writing to our nation's lawmakers, NPG President Don Mann noted, "The role of this Commission would be very simple and direct – to gather critical information and provide needed direction to the White House, Congress and other national policymakers in order to thoroughly address the myriad issues affected by population growth." He also noted that in 1970 Congress took action to create a similar Commission which was chaired by David Rockefeller and issued an invaluable report that unfortunately got caught up in the political controversies of the day and never received the White House backing it needed to make a major impact.

dollars or people – might not seem like very much. So to make the case that our nation is ill-prepared for an additional 150 million people, perhaps the best way to get their attention is to assert that we are talking about taking on population totals that are the equivalent of adding more than four new California's, or twelve new Pennsylvania's, or twenty-eight Minnesota's.

Is our nation really ready to accept such huge growth in the next 41 years – complete with the economic, social and environmental problems that will accompany it? The answer is a resounding “NO.” Yet, unfortunately too many of our elected leaders are willing to ignore this growing problem – rather than confront it. They know that to halt and reverse America's population before it becomes so totally unmanageable will involve many tough political decisions.

Recognizing this fact now underscores that we really have a dual task ahead of us.

First, each and every NPG member must pledge today to get involved in helping convince their Members of Congress to fight for making a U.S. Commission on Population Growth a reality. Then, we must make clear to our elected leaders at all levels that the population issue – complete with its tough decisions – is not another “third rail” of American politics like Social Security where doing nothing and hoping for the best will only lead to disaster.

Just like Americans are getting angry about the out-of-control spending going on in Washington, D.C. that will burden future generations with massive debt, they are also not ready to destroy the quality of life for their children and grandchildren and leave them an overpopulated nation. The political leaders who recognize that it is time to get out in front on this issue will definitely reap rich, political rewards.

To build citizen support for this important measure NPG will soon launch a campaign where each of our thousands of members and supporters will receive three pre-addressed postcards in the mail with the request that they sign and return them to their U.S. Senators and U.S. Representative. The postcards will notify the legislators of constituent support for a U.S. Commission on Population Growth and ask them to help make it a reality. We hope to drive thousands of postcards to Capitol Hill to bring attention to the immediate need to get this legislation created and moving through Congress.

In addition, in the coming weeks we are going to be aggressive in reaching out to thousands of like-minded environmental/social organizations – national, state and local – to ask them to endorse a U.S. Commission on Population Growth. It is our hope that they will also make passage of this measure part of their legislative agenda and rally their members to raise their voices in support, thus building an even larger



national grassroots movement. As these groups sign onto the fight, NPG will run ads in targeted Capitol Hill publications to highlight the growing widespread support from all across the country.

NPG does not have the funds to invest in hiring expensive lobbyists to push this measure in each individual legislator's office. That is why we are relying on people power.

Numbers count on Capitol Hill. Thankfully there are many members of Congress who are responsive to their constituents. We hope we can count on all of our members and supporters to join in this project.

AMNESTY/CITIZEN LEGISLATION DELAYED

Protracted debate over health care on Capitol Hill has delayed plans for Congress to take up immigration reform legislation that will contain provisions for amnesty/citizenship for millions of illegal immigrants. Originally promised for this fall, there is speculation that this issue may even be moved to the beginning of next year. A recent press release from Senator Schumer's office noted that the Senate is expected to act before the House on this issue, and that reform advocates who are eagerly awaiting action on this topic expect President Obama to sign a bill by the spring. NPG recently forwarded Congressional Petitions to its members and supporters urging them to make their sentiments on opposing amnesty/citizenship for illegal immigrants clear to their U.S. Senators and Congressmen. STUDENTS MAKE OUR CASE TO CONGRESS

Dear Congress...

Getting America's young people involved in the battle for a smaller, truly sustainable, population is crucial to the success of our efforts. In recent years, NPG has established a number of educational outreach campaigns, a scholarship program and a student poster contest, that have helped put the population problem front and center in classroom discussions and individual study.



This year we decided to use our NPG scholarship competition as both an educational exercise and grassroots tool by asking students to "Write a letter to their Congressman explaining that the United States simply has TOO MANY PEOPLE and requesting them to work to reverse this problem by helping to create a U.S. Commission on Population Growth."

We received more than 2,000 scholarship entries. Once they were judged they were forwarded to hundreds of individual Congressional offices to alert Members of Congress that today's generation of students is very attuned to this issue and concerned about the world they will inhabit in future decades.

In the coming months NPG will make the final decision on the topic for our 2010 Scholarship Contest. In addition, we are hoping to launch a new Student Poster Contest and perhaps initiate an Annual Multi-Media Competition whereby students will be asked to create 30 or 60 second videos which can be put on the internet to help spread the message of the important need for more young people to get involved in the fight to halt and reverse America's population growth.

THE SURVEY SAYS...

Every few months, NPG mails out tens of thousands of *National U.S. Voter Public Opinion Surveys* to gauge citizen sentiment on the population issue. We use the results we receive from throughout the country to build our grassroots campaign to reduce our nation's population growth. In addition, we compile and send the Survey results to all of the U.S. Senators and Representatives on Capitol Hill to make sure they understand that the voters are very focused on this issue and have distinct opinions on the actions necessary to rein-in our nation's population numbers.

A sampling of current questions and answers includes the following:

WHY ARE WE COUNTING PUMPKINS?

At a time when taxpayers are enraged about unnecessary government spending is it really necessary for the U.S. Census Bureau to dedicate the time, energy and effort to research and publicize the "Facts for Features" surrounding more than 25 notable days? This month a check of their website will find almost three pages of Halloween trivia including the number of potential trick or treaters (36 million – up 65,000 from a year ago), the fact that the U.S will harvest 1.1 billion pounds of pumpkins (Illinois leads the states with 496 million pounds of the orange gourd) or that there are 2,011 costume and formal wear rental establishments in the nation. Similar trivial information is available for Valentine's Day, Mother's Day, St. Patrick's Day, Cinco de Mayo, and the Super Bowl, among others. NPG has written to the Director of the U.S. Census Bureau, Robert Groves, noting that such research should be left to news organizations and other non-government entities. The focus of the Census Bureau should be limited to its original task – counting people and getting the numbers right!
