



## TO ALL MEMBERS OF THE 115<sup>TH</sup> CONGRESS

As Congress prepares to address the critical issue of immigration reform it is vital that you put America's interests ahead of the special interests.

The new immigration laws and policies that you enact in the days ahead will be nation-changing. They will affect every American for decades to come. And they will have a huge impact on our country's social, economic and environmental future.

In addressing immigration, it is imperative that you consider how your actions will affect America's population size and growth. With our nation now on track to a population of 400 million people by mid-century – only 32 years from now – this is a critical time. We can put the brakes on the vast flow of immigrants in the years ahead and put America on a path to a smaller, truly sustainable, population.

To help ensure that we meet these important goals, I am proud to speak for NPG's thousands of members and supporters in requesting that you:

- **VOTE YES** on a reasonable and workable solution to the problem of young people presently covered under the DACA program;
- **VOTE YES** to end current 'chain migration' policies that will limit new citizens to sponsoring only a spouse and minor children. [This change alone could cut annual U.S. population growth by 350,000.];
- **VOTE YES** to mandate E-Verify for all employee hiring;
- **VOTE YES** to further strengthen our nation's borders;
- **VOTE YES** to strongly penalize those who overstay their worker, student and tourist visas and remain in our country illegally;
- **VOTE YES** to end the present Visa Lottery;
- **VOTE YES** to limit birthright citizenship to children born on American soil only to U.S. citizens and legal resident aliens;
- **VOTE YES** to place and firmly enforce an annual cap on the number of refugees admitted; and
- **VOTE YES** to permanently cap the overall yearly number of admissions of legal immigrants at a number significantly lower than the present volume of entries.

**Perhaps most important of all, please act on the above issues NOW!** Every day that we permit the immigration crisis to grow and fester only feeds future problems.

In short, this is not the time for political wavering. It is time for you and your Congressional colleagues to end debate – and deliver responsible, workable, common sense immigration



solutions. In doing so, we can finally take the first steps toward reducing America's population to a truly sustainable size.

The American people's current demands on Congress to fix our broken immigration system is a timely wake up call for all of us to focus on the dire threat that overpopulation poses for our nation. We definitely owe it to our children and grandchildren to address that threat today before it is too late. As you work to fix immigration please also do all you can to slow our nation's disastrous population growth that – if left unchecked – will only feed future social, economic and environmental problems.

While we've all heard a lot about "dreamers" in today's immigration debate, it is important to emphasize that all Americans – those born here, long-time legal residents, and new arrivals – share the dream of a livable future.
