CENSUS REVEALS 50 FASTEST-GROWING METRO AREAS

Numbers Show Some Areas With Huge Population Gains

The U.S. Census Bureau reported in early April that the Atlanta, GA metro area posted the largest numerical gain of the nation's 361 metro areas by adding 890,000 residents from April 1, 2000 to July 1, 2006. Atlanta's population, which stood at 4.11 million in 2000 skyrocketed to more than 5 million and continues to grow at an alarming rate.

Similar population booms are impacting other cities. Dallas - Fort Worth, TX added 825,000 people in six years and broke the 6 million mark; Houston, TX saw an increase of 850,000, taking it's population to just short of 5.5 million; Phoenix, AZ added 787,000 people for a population a bit over 4 million; and Riverside-San Bernadino-Ontario, California registered an increase of 771,000.

These new figures show that 14 metro areas in the U.S. now have populations of 4 million or more.

The Census Report cited a loss of 292,000 in the New Orleans, LA metro area, a 22.2% decline, as well as a 7.4% decline in Gulfport-Biloxi, MI – resulting

from Hurricane Katrina. Two other major cities where population is decreasing include Pittsburgh, PA (a loss of 60,000) and Cleveland, OH (a loss of 34,000).


The 50 fastest-growing metro areas were almost evenly divided between the South and West – 23 in the West and 25 in the South. Of the 50 fastest-growing locales, not one was in the Northeast.

The Census data found that more than 80% of all U.S. metro areas (305 out of 361) had a larger population on July 1, 2006 than on April 1, 2000. It also noted that as of July 1, 2006 – a total of 249.2 million people, or 83.2% of the U.S. population – lived in metro areas.

Looking at the growth rates on the following chart, it is easy to understand how so many small and mid-sized communities across the nation are overwhelmed trying to cope with today's massive population growth. Note that CO, FL, NV, NC, GA and AZ are states absorbing huge numbers of illegal immigrants.

THE PRESIDENT'S LETTER



A message from NPG President Donald Mann

In a recent speech focusing on immigration, President Bush stated: "This problem has been growing for decades, and past efforts to address it have failed. These failures helped create a perception that America was not serious about enforcing our immigration laws and that they could be broken without consequence."

Those two sentences clearly demonstrate how the "blame game" works in Washington, DC. Even before 9/11, the Bush administration could have led the charge to secure our borders and keep millions of illegals out of our country. It did not. The words "create a perception" are the icing on the cake; in fact, there is no perception about it. The reality is that our government has not been serious about enforcing our immigration laws in the past and does not appear to be serious even today. Except for a few wellpublicized raids by Immigration Customs Enforcement agents on select factories in the past few months, enforcement of immigration laws has been almost non-existent across the country.

All of this leads to a key question: Are we, as a nation, finally going to get tough on illegal immigrants or adjust our policies and laws to make life convenient for them?

Few organizations have been as out-front and vocal on the vital need for strict immigration laws as NPG. We have spent 35 years keeping Congress abreast of research and facts to help guide our nation on this issue. We constantly remind our Senators and Congressmen to look down the road and understand the demographic consequences of unrestricted immigration. It is vital that they put our nation's long-term security foremost when writing any new immigration laws, rather than acting out of political expediency.

This year's Congressional debate on immigration is starting out as a tangled mess of ideas and is sure to have a twisted, uncertain road ahead. Such a high-stakes piece of legislation will bring out all the arm-twisters and high-power lobbyists. Business, labor, immigrant-rights advocates, churches, farmers, and a horde of other special interest groups are going to spend millions pushing their individual agendas. Add to this the growing political pressure on the part of both Democrats and Republicans to pander to the growing Hispanic vote, and there is no telling what kind of legislation will result.

My greatest concern is that Congress is trying to do too much at one time – especially when there is absolutely no semblance of organization in place to effectively follow through on legislation to "legitimatize" 12-20 million illegals. How would they monitor their leaving the country or paying any fines? Most alarming is the fact that the same bureaucrats at the Department of Homeland Security who let today's immigration crisis spin out of control would be in charge of resolving these same issues in the next few years.

Remember, the current debate over illegal immigration is not only about our quality of life in 2007. It's about 2025, 2050, 2075...and many years ahead. With the odds of many children born today living into the 22nd Century, every American owes it to future generations to make sure they can grow and prosper in a safe, livable and sustainable environment. The alternative is to put our nation on track to spin into a cycle of destructive social, economic and environmental chaos.

If ever there was a time to raise your voice and increase your activism in the population/immigration battle, it is now. Here at NPG, we know we cannot change the world overnight, but the activism of our tens of thousands of members may be able to change some votes on Capitol Hill – votes that make a difference! Please pay attention to this debate in the coming months – and let us hear from you that you are behind us 100% with your support.

WHATEVER HAPPENED TO RESPECTING THE LAW?

The well-respected firm of Zogby International recently completed a national poll for the organization Judicial Watch that contained some very interesting numbers. It found that 66% of likely voters believe that more emphasis should be placed on law enforcement when addressing the issue of illegal immigration. However, when the poll numbers are looked at from the opposite angle, the results are quite troublesome. Can it be true that 34% of Americans cannot go on record in support of more law enforcement when it comes to dealing with illegals? Such beliefs held by large numbers of voters underscore the huge problems our nation, states and communities face in enacting and enforcing laws designed to rein-in and curb illegal immigration.

As part of NPG's 35th Anniversary celebration, we are proud to reflect on the wisdom and insight shared by so many of the notable scientists, researchers and academics who have shared our goals and helped to advance our mission. The following is a short excerpt from an introduction titled "The Human Way" that celebrated author Isaac Asimov penned as an Introduction to NPG President Don Mann's 50-page booklet titled *Urgently Needed Now: A National Policy to Reduce U.S. Population*, published in 1980.

"....Of all the species on Earth, only the human being, as far as we know, is blessed with foresight; only we know the past and visualize the future. All other species, as far as we know, live in the present only. Why, then, must we behave as other species do?

Why can't we limit population, or even decrease it, voluntarily, before the catastrophe strikes? And why can't we do it by some other means than by raising the death rate?

We are the only life-form intelligent

enough to understand the mechanics of the reproductive process. Instead of waiting for the rise in the death rate, can we not deliberately and voluntarily lower the birth rate? We can underuse our reproductive capacity. We can limit our replacement potentiality....

This is not nature's way, but it is the *human* way, and of what value is it to be human if, in this supreme crisis of the human species, we behave like unintelligent animals?"

IT'S THE NUMBERS, STUPID!

Making Sure Congress Understands What's At Stake

As the national debate over immigration — both legal and illegal — gains more traction, dozens of organizations are launching massive campaigns to focus the public and Members of Congress on one or more aspects of what is at stake. Jobs, housing, separation of families, cultural impacts, and a host of attendant problems, certainly figure into the debate.

Here at NPG, we share the concerns about these issues. Rather than deluge Congress with truckloads of reports and scientific surveys, we've learned that numbers can be very persuasive. Telling our fellow citizens and officeholders at all levels that soaring population growth is already overwhelming many cities, counties and states simply reinforces something they can already see with their own eyes. Using real numbers based on the U.S. Census Bureau's interim projections to show that America must brace to absorb more than 100 million people in the next 43 years quickly draws attention. It is difficult for anybody to look at that figure without asking: Where will we put all these people?

NPG is determined to make future population numbers central to the coming immigration debate in Congress. During the immigration debate last year, few things astounded Senators more than the tangible numbers projecting a surge of 60 million additional people over and above current population projections in the next two decades if our nation continues down the wrong path on this issue.

Before this year's immigration debate commences on Capitol Hill, NPG will forward a copy of *It's the Numbers, Stupid!* to all Senators and Congressmen. In addition, we will continue to work to derail major parts of

the proposed legislation by building our advertising and education efforts around the disastrous consequences of lax immigration laws, chain-migration (immigrants bringing their extended family to the U.S.) and any "politically correct" policies that fail to effectively crack down on illegal immigrants who break the law.

Population Policy.

A forward-looking Governor, Sanford has already acknowledged that his state is "at the tipping point" and the conference was aimed at addressing traffic, water quality, development, and other issues being driven by the state's rapidly rising population. In a state confronted with a soaring population that is expected to absorb more than 1.1 million additional people by 2030 (current population is approximately 4,250,000), he recognizes that long-term planning is essential. Estimates forecast that his state will need 525,000 housing units, 40 million square feet of office space, 45 million square feet of retail space, and 13,000 hotel rooms over that same time period.

It is not easy to get all of the various factions involved in these areas to agree on what needs to be done. Governor Sanford should be praised for getting everybody into one room to begin talking about the role they can play to lessen population pressures.

As can be expected, the conference exposed the giant rifts that exist in any long-range planning.

Some groups, such as the Home Builders of South Carolina staked claim to their rights stating that, "land use initiatives should be used as a tool to manage our growth and not stop growth." Pressure in the state is building to protect more of the fragile wetlands along the coast where there has been a giant housing boom in recent years.

Ann Timberlake, executive director of the Conservation Voters of South Carolina noted that, "At the local level, folks are concerned with the sprawl and traffic and the way that their communities are changing...Our quality of life is one of the reasons people come to South Carolina, and we need to act now if we're going to preserve our look and feel for future generations."

Governor Sanford asserted, "The debate over how our state develops in the near future is one that every South Carolinian should care about."

We applaud Governor Sanford in proving that he is open to putting the spotlight on population issues. We urge all members throughout the country to pressure their Governors to follow Governor Sanford's lead.
